### SECTION 3 — HAZARDS IDENTIFICATION

\*\*\*POTENTIAL HEALTH EFFECTS\*\*\*

**Routes of entry:** Inhalation, ingestion, skin and eye contact.

**Signs and symptoms of short-term (acute) exposure:**

*Inhalation:* Moderately irritating to the eyes, nose, throat and lungs. High concentration of vapours will cause irritation, or if inhaled as a mist.

*Skin contact:* Dangerous in case of skin contact.

*Eye contact:* Contact can result in irritation.

*Ingestion:* Harmful if swallowed.

**Effects of long-term (chronic) exposure:** See Section 11. **Other important hazards:** None reported.

### SECTION 4 — FIRST AID MEASURES

**Inhalation:** Remove victim to fresh air. If symptoms persist, call a physician.

**Skin contact:** Flush skin with plenty of water, for at least 15 minutes, while removing contaminated clothing. Call physician immediately. Wash contaminated clothing before reuse.

**Environmental effects:** Alcohol ethoxylate, citric acid and sulphonic acid are readily biodegradable and as such full formulation testing would be expected to be readily biodegradable under OECD 301 D .

Aquatic toxicity for alcohol ethoxylate to fish and daphnia would be between 1-10 mg/L and would be classified as low toxicity.
